- b. State Senate District Plans Brian Sanderoff summarized concept maps A – C. (00:31:00)
- c. State House District Plans Michael Sharp summarized concept maps A – E (00:51:00)

The Chair moved that Center for Civic Policy State House plan #4714 now displayed be replaced with new Civic plan #4968 now under 10% deviation and displayed as a concept map. Seconded by Member Curtis. Chair Chávez conducted a vote. All Committee Members voted in the affirmative, and the motion was approved unanimously. (01.17.00)

- d. Public Education District Plans. Michael Sharp summarized concept plans A – C (02:16:00)
