1. Opening remarks

The Chair provided brief opening remarks, that the purpose of the meeting is to hear testimony on the concept maps moved forward from the September 16 meeting, and the Chair reviewed requirements for redistricting maps by the Committee. (0:01:30)

2. Presentation of district plans and public comment

- a. Congressional District Plans. Brian Sanderoff of Research & Polling summarized the concept maps A – G plus new map just submitted by the Center for Civic Policy. (0:05:30)
- b. State Senate District Plans. Brian Sanderoff summarized concept maps A – C. (02:31:00)
- c. State House District Plans. Michael Sharp of Research & Polling summarized concept maps A – E. (03:09:00)

Committee Member Saucedo moved to move map #58944 forward for public consideration; Committee Member Cangiolosi seconded. Hearing no further discussion, Chair Chávez conducted a vote. All Committee Members voted in the affirmative, and the motion was unanimously approved.

Committee Member Michael Sanchez moved to move the Chamber of Commerce map forward for public consideration; Committee Member Cangiolosi seconded. Hearing no further discussion, Chair Chávez conducted a vote. All Committee Members voted in the affirmative, and the motion was unanimously approved.

- d. Public Education District Plans. Michael Sharp summarized concept maps A – D. (4:32:30)

Committee Member Curtis moved to have the Native American PEC map move forward for public consideration; Committee Member Rhatigan seconded. Hearing no further discussion, Chair Chávez conducted a vote. All Committee Members voted in the affirmative, and the motion was unanimously approved. (04:48:00)

Chair Chávez explained the process going forward. Next meeting is October 15, 2021, when the CRC will adopt maps. If unable to complete the work

the meeting will be recessed and carried over to the following week. Once maps are adopted the CRC must prepare a narrative evaluation explaining the preservation of communities of interest, VRA compliance, a partisan fairness measure which will be performed by Professor David Cottrell.
